FROM THE BILLING DEPARTMENT



The Postal Service states it takes 1-5 business days for a piece of 1st class mail to get from point A to Point B. We are getting many reports from members that the delivery times for their bills is taking much longer than that. We cannot control the speed of the mail, and understand holidays, weather and other issues can slow down delivery times. We can suggest that customers utilize other options at their disposal, and we are even offering a \$20 incentive to customers that sign up for one of the following bill pay options and eliminate their paper bill.

Electronic Fund Transfer (EFT)- you can set up for your bill to be automatically debited from your bank account on the 20th of each month.

Smart Hub-View your bill electronically through SmartHub and authorize payment from your checking account or credit/debit card. Through SmartHub, you can view your billing, payment and patronage capital history.
