We can now offer you a website that not only will inform you that the bill is available, but in addition, allow you to access all information concerning your service, such as usage information, past billing, and payment history. This new site is available both online and via smart phone application (please contact the office to get instructions concerning the smart phone access). Unfortunately, at this time, you will NOT be able to pay your bill online, but we are offering an ACH option of payment. To sign up for this payment option, fill out the form and send in to the NEA office.

To sign up for SmartHub access, you will need the following information:

Your account #, Last Name or Business Name, email address, SSN or TIN, and the Zip code on your bill.
 You may need to contact our office prior to attempting to sign up on the site in order to provide the SSN or TIN information as many of our accounts do not have that in-

Auto Bill Pay

NEA is pleased to announce that we are offering a convenient Automatic Payment Plan for your monthly electric bill. Under the new plan, your electric bill can be paid directly from your bank account on the 20th, or the first business day after, of each month. Proof of payment will appear with your monthly bank statement.

Questions & Answers:

What is the Electronic Funds Transfer / Auto Bill Pay?

The Auto Bill Pay Plan is a method by which NEA draws money from your bank account each month to pay your electric bill.

What is required to be eligible for the Auto Bill Pay?

To be eligible, the consumer's credit history with NEA for the past 12 months must not indicate a returned check.

How does the Auto Bill Pay work?

Once you sign up, you will receive your bill each month as usual. Included on the bill will be the statement, "BANK DRAFT DO NOT PAY". This notifies you that your bill will be drafted and the date of draft.

Is there a charge for this service?

No, neither NEA nor your bank will charge you for this service.

When will my account be drafted each month?

The bank drafts will be processed by your bank on the 20th, or the first business day after, of each month.

Can I cancel whenever I wish?

You can cancel at any time with written 5-day notice to NEA.

How do I sign up?

If you are interested, please stop by and fill out an EFT Agreement. Include all the information requested. Be sure to attach a voided check from your bank account. Deposit slips are not acceptable.

Why is the draft day not the same as bill due date?

The difference in date is to accommodate all due dates for all types of accounts.

We need to work out testing the systems and for credit cards, who will bear the transaction fees, but more options are coming available soon.
