Nominations can be made by petition of 15 or more members acting together. **Nominations by** petition must be submitted at the NEA office no later than April 18th to be printed on the ballot.

Welcome to the start of the new year! With the new year comes new activities and plans for 2017. The biggest of those is the work plan rebuild of about 15 miles of line along Highway 270 from the bottom side of 77 Hill to Lance Creek. We had the bid opening in early January and it came in lower than we had expected the project to cost, so we will be extending the length of the rebuild a couple miles to take in more deteriorated line. We may also use the contractor to install some new poles close to the Van Tassell sub to allow for us to take it out of service for major maintenance.

Another project we are looking at is an additional building for the Harrison outpost. Through the years, the equipment that we use has been getting larger. The latest bucket truck that will be arriving in the spring will be the last straw that will put us at or beyond the capacity of the buildings that we currently have. The new building will house the two biggest pieces of equipment, the bucket and the digger truck, as well as better material storage with a little room for growth. We hope to get many years of good service from the new building.

As you can see by the earlier article, it is already time to start thinking about Annual Meeting. The start of the process is the Nominating Committee, with notices and Annual Meeting following in May. Time flies, the good news is that is also about how far we are from spring and summer weather.
