In April, Lineman Appreciation Day is celebrated. At NEA, we enjoyed the company of students with the Wyoming Early Child and Family Center.

Students presented NEA line men with a wonderful friend-ship rock with a painting and verse on it and lineman took the kids on a safety instruction tour around our facility. They saw bucket trucks and the skid steer in action, along with pole climbing. They also got hands on with personal protective equipment the crew wear to keep them safe around electricity.

Abandoned high voltage power line has built up over years on NEA's system, as new lines have been built, becoming a hazard and an unfunded maintenance/tax issue. Removing such line has moved up on the list of priorities line crews are addressing this year, making the new wire winder a welcome piece of equipment.

As seen in the picture above, the wire winder attaches to our skid steer and is used for spooling up wire for salvage. Wire that can be salvaged supplements funds for replacing small equipment and tools. The upgrade was made because previous equipment only allowed crews to wind up 1500 feet of removed power line at time and two crew members were need. The new wire winder will accommodate 2,000 lbs of wire or about 5 miles of line and only needs one operator, improving efficiency.



Please, either hang on to that notice and plan to attend the meeting or ask around to folks you know that might be coming to Harrison on the 17th and give them your proxy card. If you do the proxy card option, be sure to print & sign it with the name that your account is in for it to be valid. I look forward to seeing many of you there. Last year we had an amazing turnout in Lusk despite the less than spring like weather. We'll have the usual financial presentation, as well as upcoming projects, updates from our state-wide association and Senior Vice President of Generation from Tri-State there.

We need to be sure to do our best to meet the quorum to have an "official" meeting. We've had a few years where we were close to not making it. How can you help? Watch for your annual meeting notice in the mail. If attending, bring your own notice with you. Ask your neighbors if they are attending and if not, if you can be their proxy. If you will not be attending, please fill out your proxy and get it to someone who will be there. Any member is allowed to be a proxy for up to 5 others, if they hold the proper proxy cards. This year's meeting doesn't have any contested races, or major issues, but I'd hate to see us get into a situation where we need quorum and can't make it. A few coops in the state have had the issue of not making quorum in past years. We have come close, but never missed. I do want to thank the dedicated members that show up to support the NEA in this business function of your electric coop.

Spring is also on the way (if the snow ever stops), with that means more activity in the pastures and back country. Please keep an eye open when working near NEA lines and poles. Winter brings many stresses to our lines, including ice and wind that can cause insulators, poles, or anchors to break or come loose. The wind and ice that we have seen in the past few months didn't do much damage significant enough to cause widespread outages but may have caused damage to some less critical parts that may present an issue in time. If you see something that doesn't look right, please keep yourself and any livestock a safe distance away and notify the office as soon as you can.
