Once your Smarthub account has been created, your home screen will look like this. From this screen you can use the drop boxes on Billing & Payments, My Profile, My Usage, Notifications, etc to see your bills, go paperless, set up auto pay, review usage, receive notifications, and more.

The Smarthub site is very user friendly. If you have issues using the site, please feel free to call our office and visit with Julie in Billing for support.

The addition of Smarthub has been extremely useful to our members and the cooperative. We encourage everyone to use this option for information and payment.



If you see downed power lines, or other damaged electrical equipment, notify NEA as soon as possible because the lines could be live. Just because power lines are damaged does not mean they are dead. Stay away, and instruct others to do the same. Power lines do not have to be arcing or sparking to be live and dangerous. Downed power lines, stray wires, and debris in contact with them all have the potential to deliver a fatal shock. Stay clear of fallen power lines and damaged areas that could hide a hazard. Treat all power lines as if they are energized until there is certainty that power has been disconnected. If a power line has landed on the ground, there is the potential for the area nearby to be energized. Stay far away. Do not attempt to drive over a downed power line.

It is the responsibility of the Nominating Committee to meet and officially nominate persons they have reviewed and qualified as able to serve on the NEA Board of Directors.
